



# St Dennis Parish Council Co-Option Policy and Procedure

## INTRODUCTION

This policy sets out the procedure to ensure there is compliance with legislation and continuity of procedures in the co-option of members to St Dennis Parish Council. The co-option procedure is entirely managed by the Parish Council, and this policy will ensure that a fair and equitable process is carried out.

## 1. CO-OPTION

The co-option of a parish councillor occurs in two instances:

When an ordinary vacancy has arisen on the Parish Council after the ordinary elections held every four years, or when a casual vacancy has arisen on the Parish Council and no by-election has been called.

### A. Ordinary vacancy

An ordinary vacancy occurs when there are insufficient candidates to fill all the seats on the Parish Council at the ordinary elections held every four years. Any candidates who were nominated are automatically elected to the Parish Council and any remaining vacancies are known as “ordinary vacancies”. Provided there are enough parish councillors to constitute a quorum, the Parish Council is generally able to co-opt a volunteer to fill the vacancies. In some cases, Cornwall Council may intervene and make an appointment or order an election to fill the vacancies.

### B. Casual vacancy

- i. A casual vacancy occurs when:
  - A councillor fails to make his declaration of acceptance of office at the proper time;
  - A councillor resigns;
  - A councillor dies;
  - A councillor becomes disqualified; or
  - A councillor fails for six (6) months to attend meetings of a council committee or sub- committee or to attend as a representative of the council a meeting of an outside body.
- ii. The Parish Council must notify Cornwall Council of a casual vacancy and then advertise the vacancy and give electors for the ward the opportunity to request an election. This occurs when ten (10) electors write to Cornwall Council stating that an election is requested.
- iii. If a by-election is called, a polling station will be set up by Cornwall Council and the people of the Parish will be asked to go to the polls to vote for candidates who will have put themselves forward by way of a nomination paper. The Parish Council will pay the costs of the election. The people of the Parish have fourteen days (not including weekends, bank holidays and other notable days), to claim the by-election, but the Electoral Services Office of Cornwall Council will advise the Clerk of the closing date.
- iv. If more than one (1) candidate is then nominated a by-election takes place but if only one (1) candidate is put forward they are duly elected without a ballot. If ten (10) residents do not request a ballot within fourteen (14) days of the vacancy notice being posted, as advised by the Electoral Services Office, the Parish Council is able to co-opt a volunteer.

## 2. CONFIRMATION OF CO-OPTION

- A. On receipt of written confirmation from the Electoral Services Office that no poll (by-election) has been claimed, the casual vacancy can be filled by means of co-option. The Clerk will:
- Advertise the vacancy on the Parish Council notice boards, website, social media and local publications.
- B. This procedure will also apply in the case of an ordinary vacancy where the Electoral Services Office has confirmed that there were insufficient nominations to fill all the seats but there are sufficient parish councillors elected to constitute a quorum.

## 3. ELIGIBILITY OF CANDIDATES

- A. The Parish Council can consider any person to fill a vacancy provided that:
- he/she is 18 or over; and
  - he/she is a British citizen or a qualifying Commonwealth citizen; and at least one of the following apply:
    - he/she is an elector for the Parish and continues to be an elector; or
    - has resided in the Parish for the past twelve months or rented/tenanted land in the Parish; or
    - has had his/her principal or only place of work in the Parish for the past twelve months; or
    - has lived within three miles of the Parish for the past twelve months.
- B. There are certain disqualifications for being a parish councillor, of which the main are (see s80 of the Local Government Act 1972):
- holding a paid office or employment under the Parish Council;
  - bankruptcy;
  - having been sentenced to a term of imprisonment (whether suspended or not) of not less than three months, without the option of a fine during the preceding five years; or
  - being disqualified under any enactment relating to corrupt or illegal electoral practices.

## 4. APPLICATIONS

- A. Although there is no statutory requirement to do so, candidates will be requested to:
- Attend at least one Parish Council meeting as observers;
  - Submit information about themselves, by way of completing a short application form (a copy of the application form is attached as Appendix A);
  - Confirm their eligibility for the position of parish councillor within the statutory rules, (a copy of the eligibility form is attached as Appendix B).
- B. Following receipt of applications, the next suitable Parish Council meeting will have an agenda item 'To receive written applications for the office of Parish Councillor and to co-opt a candidate(s) to fill the existing vacancy (vacancies)'. Eligible candidates will be invited to attend the meeting.
- C. Copies of the eligible candidates' applications will be circulated to all parish councillors by the Clerk at least 3 clear days prior to the meeting of the full Parish Council, when the co-option will be considered. (See Para 6 Specifications for a co-opted councillor for essential and desirable skills).
- D. All such documents will be treated by the Clerk and all parish councillors as strictly private and confidential.

## 5. THE CO-OPTION PROCESS

- A. If the number of applicants for a single seat exceeds 3, the applications will be heard informally at a specially convened meeting to allow candidates and members sufficient time to receive the application and facilitate time for questions and answers. No resolution, voting or decisions will be made at this meeting. This meeting is to allow for an appropriate period of information sharing between members and applicants.
- B. If there are less than 3 applicants they will be invited to the next Full Council meeting where co-option will be discussed. Candidates will be given five minutes maximum to introduce themselves to the parish councillors (members), give information on their background and experience and explain why they wish to become a member of the Parish Council. Members will be allowed to ask questions of the applicants.
- C. At the next available full council meeting, the press, public and applicants will be asked to leave the Council Meeting, in order for the applications to be considered. There are no set rules regarding how a Council co-opts a member. Members may choose who they like but the applicant must be qualified to have been a candidates. After voting has taken place the press, public and applicants will be asked to re-join the meeting and the result will be declared.
- D. A recorded vote may be requested under Standing Order 8 to show whether each councillor present and voting, gave his/her vote for or against that question. Legislation does not provide for a proxy or postal vote.
- E. For a candidate to be co-opted to the Parish Council, it will be necessary for them to obtain an absolute majority of votes cast (50% + 1 of the votes available at the meeting). If there are more than two candidates and there is no candidate with an overall majority in the first round of voting the candidate with the least number of votes will drop out of the process. Each councillor must vote, no abstention allowed. The Chairman may only use their casting vote if two successive voting rounds are stalemated.
- F. Further rounds of voting will then take place with the process repeated until a candidate has an absolute majority.
- G. If present, a candidate who is co-opted will sign at the co-option meeting a Declaration of Acceptance of Office, including an undertaking to abide by the Parish Council's Code of Conduct, and may take office thereafter. If not present, a co-opted candidate will sign the Declaration of Acceptance of Office either before or at the next meeting of the Parish Council.
- H. The Clerk will notify Cornwall Council Electoral Services Office of the co-option of the new parish councillor.
- I. The co-opted parish councillor will complete a Notification of Disclosable Pecuniary and Other Interests form which the Clerk will lodge with the Monitoring Officer at Cornwall Council within 28 days of the co-option.
- J. If insufficient candidates are co-opted, the process should continue, whereby the vacancies are again advertised.

## St Dennis Parish Council Co-Option Eligibility Form

**1. In order to be eligible for co-option as a Parish Councillor you must satisfy certain criteria.**

**You must satisfy (a) and (b) below and at least one of the options (c) – (f). Please tick which apply to you:**

- a. I am 18 years of age or over; and ☐
- b. I am a British citizen or a citizen of the Commonwealth ☐
- c. I am registered as a local government elector for the parish; **or** ☐
- d. I have, during the whole of the twelve months preceding the date of my co-option ☐ occupied, as owner or tenant, land or other premises in the parish; **or**
- e. My principal or only place of work during those twelve months has been in the parish; **or** ☐
- f. I have during the whole of those twelve months resided in the parish or within 3 miles of it. ☐

**2. Please note that under Section 80 of the Local Government Act 1972 a person is disqualified from being a parish councillor if he/she:**

- a) Is employed by the parish council or holds paid office
- b) Is employed by an entity controlled by the parish council;
- c) Is the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions order or a debt relief restrictions order or an interim debt relief restrictions order; or
- d) Has within five years before the day of co-option, or since his/her co-option, been convicted in the UK, Channel Islands or Isle of Man of any offence and has been sentenced to imprisonment (whether suspended or not) for not less than three months without the option of a fine; or
- e) is otherwise disqualified under Part III of the Representation of the People Act 1983 (relating to corrupt or illegal electoral practices and offences relating to donations) or the Audit Commission Act 1998.
