- **Application 06/26** – Request received for funding of £2573 towards college course fees. The applicant has benefited from the scheme previously. It was **Resolved**, proposed and seconded to award a partial grant of **£1150** as any more would exceed the £3000 over five years limitation of the funding criteria. All present in favour.
- **Application 07/26** – Request received for total funding of £900 to support a college course. It was **Resolved**, proposed and seconded to award, in principle subject to receipt of additional information, a total of up to **£580** (Laptop capped limit of £400, Printer capped limit of £100 and course kit of

£80), no funding will be granted for fuel costs. Committee members voted with 4 in favour and 1 abstention. Motion Carried to approve the grant.

- **Application 08/26** – It was **Resolved**, proposed and seconded to approve the grant request of **£272** for a laptop to support GCSE studies. All present in favour.
