Cllr Greenslade informed the council that he had been approached by a member of the public concerned that her daughter had been approached by a man in the cemetery behaving strangely.

Cllr Greenslade also reported lorries having difficulties with diversions due to the recent road closure, the clerk informed Cllr Greenslade that this has been an issue and the relevant authorities had been contacted that day to request better signage for the duration of the works.

- a) Councillor Greenslade reported:  
During a recent planning meeting the eco village at Scredda had been approved and that there is a twenty-year timescale for the completion of the works, a technology centre is in the process of being erected in the same area and the proposed college near Scredda has been refused once again.
- b) The members of the public that were present to enquire if there has been an update on the issues regarding footpath 18 which were reported last month. They were informed that this is ongoing at present as the time scale given had not yet expired. **Action – Cllr Mrs J Clarke will contact the countryside ranger to receive an update.**
