a) **Public Participation:** 

Cllr Ms S Kelsey enquired where the plans were with the telephone box, the clerk explained that we are waiting on members of the public to come forwards with ideas for future use, Cllr Bates has offered to paint the telephone box, and this is an ongoing process.

Cllr Ms S Kelsey reported that there have been two incidents of graffiti at the bus shelter at Hendra downs that have been covered over. All Cllr's were reminded that incidents such as this need to be photographed and reported to the police office and the police.

b) Cornwall Councillors Report: Cllr Greenslade commented that there seems to have been an improvement with the parking issues in the village since the parking enforcement officers have been in attendance. Recently Cllr Greenslade has received an increase in complaints regarding dog fouling within the village, and there has also been an increase in horse riders using mobile phones whilst riding. The horse-riding issue was discussed with no clear way forward known at this point in time.

Cllr Greenslade also spoke of the recent broadcast of the CERC not producing electricity. Cllr Mrs J Clarke added to this informing all present that Suez hope to have the repairs carried out by the end of February.
