**PF 14/17 – To adopt the minutes dated 5<sup>th</sup> July 2017.**

**PF 15/17 – To discuss the opening of the park.**

It was discussed and agreed to open the park on Saturday 26<sup>th</sup> August 2017 at 10am. The deputy clerk advised that there had been no reply from Natasha Swift St Austell Voice concerning Jonathan Fox opening the park, and she advised if nothing heard by 8<sup>th</sup> August to use someone else. It was agreed to invite Natalie Chard Community Liaison Officer from Cornwall Energy Recovery Centre. To invite the following: Natasha Swift St Austell Voice, Rev Paul Arthur to bless the opening, Cllr Fred Greenslade, Nanpean and Community Trust. It was agreed firstly, to bless the park, open it, Cllr Clarke (Chair), Community Trust to make a speech and Cllr Greenslade if he would also give a speech. It was agreed for posters on the notice boards, media, website, local shops and pubs etc. To keep it simple and no refreshments. To obtain a gold ribbon to tie to the front entrance of the new children's park for the official opening.

**PF 16/17 - To discuss and agree if New Moor Rovers can use the park.**

Cllr Bell advised the committee there is no room for Newmoor Rovers at St Dennis AFC, due to too many teams. He advised that there is enough room for a full- size football pitch in the park. It was advised that the nets need to be higher, so the ball does not go into property next to the park. Cllr Bell advised that there will be sewage tank, electricity, a building, which can be used for Brownies, Clubs and groups etc. Cllr Clarke advised that this must be checked with Tregothan Estate, who are the owners of the park for permission to use the park. Cllr Kelsey asked to what level New Moor Rovers could achieve, and Cllr Bell advised

only at a Junior level. Cllr Panks requested plans and for a representative to attend the next meeting. The clerk asked for contact details of New Moor Rovers and Cllr Bell stated he would email these.
